- a. Senior leadership conversations: intersections of advising and technology (Dr. Claire Robinson)
 - i. What is Hyland? How will it be used?
 - 1. Education software that manages records: Registrar, Admissions, Transfer

- 2. Hyland can provide automation to capture transcript images and gather course information. This is to reduce manual entry and streamline.
- 3. Joint access point for Registrar and Transfer teams.
- 4. Potentially affords a "one transcript email"

 - 1. Adoption of Student Educational Planner in DegreeWorks
 - a. A full adoption of SEP would assist greatly with course needs
 - b. Increased student enrollment and increased student retention are creating additional demand for classes
 - c. SEP reports can assist with faculty hiring.
 - d. Mike Dial and Brian Dusel are contacts for SEPs.
 - e. The first phase of reporting is designed to offer a preview of registration needs; a second phase of reporting can focus on dynamic needs.
 - f. HRSM has a strong history of SEP usage and can offer context to interested parties. (S.R.)
 - g. Question: How far out should the SEP be projected? 2 semesters?

 - ii. FAFSA:
 - 1. 25-26 is on a positive start: approximately 20,000 applicants
 - 2. There are some national issues regarding students with undocumented family members who are hearing news not to fill out certain portions of the FAFSA. Advisors can send student names and IDs to Joey Derrick.
